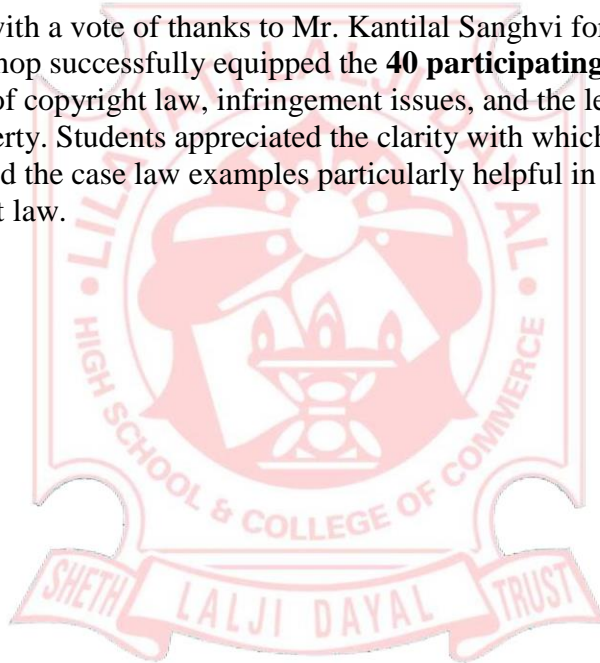

4. Challenges Faced by Start-Up Founders:

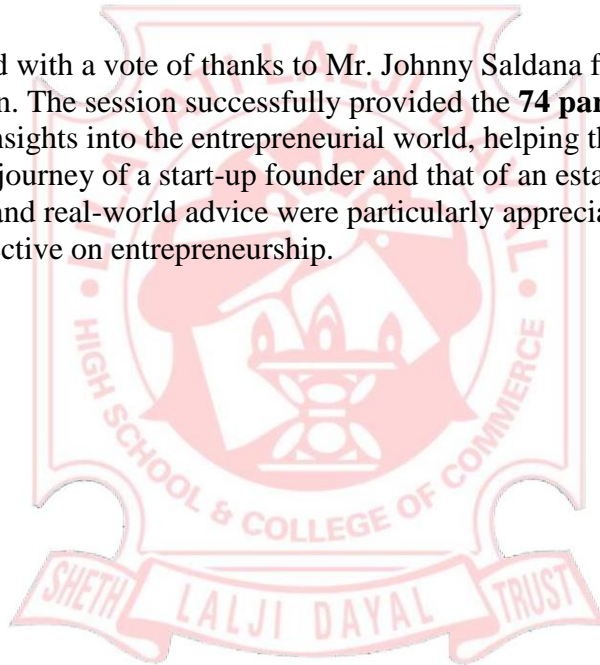
- The guest speaker outlined the key challenges that start-up founders face, including securing capital, building a team, and dealing with market uncertainty.

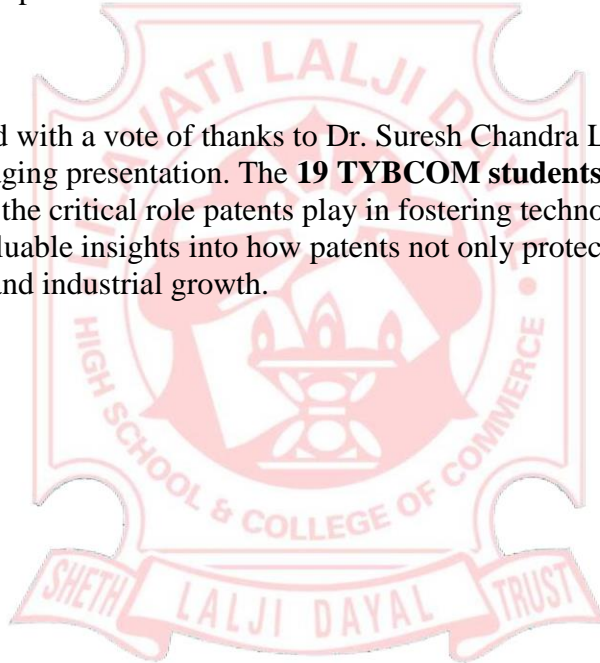

5. Entrepreneurial Mindset:

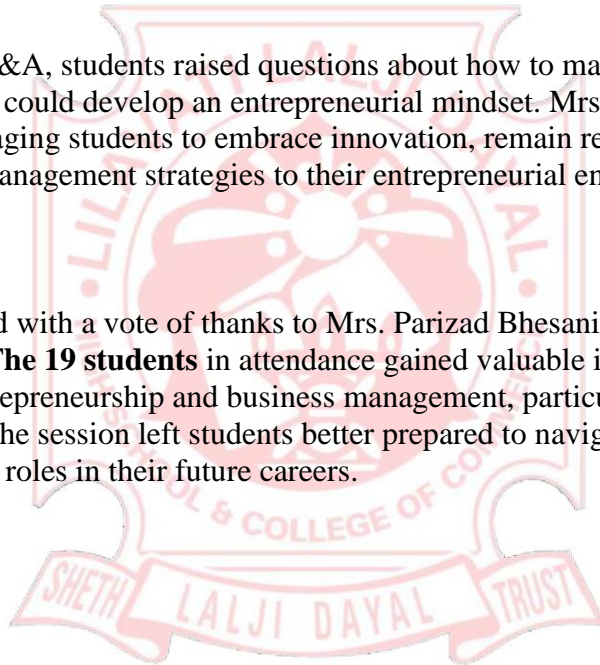

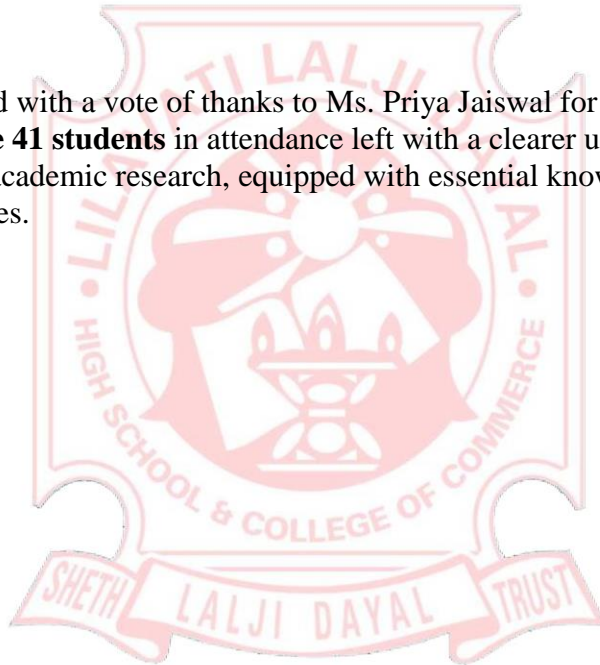

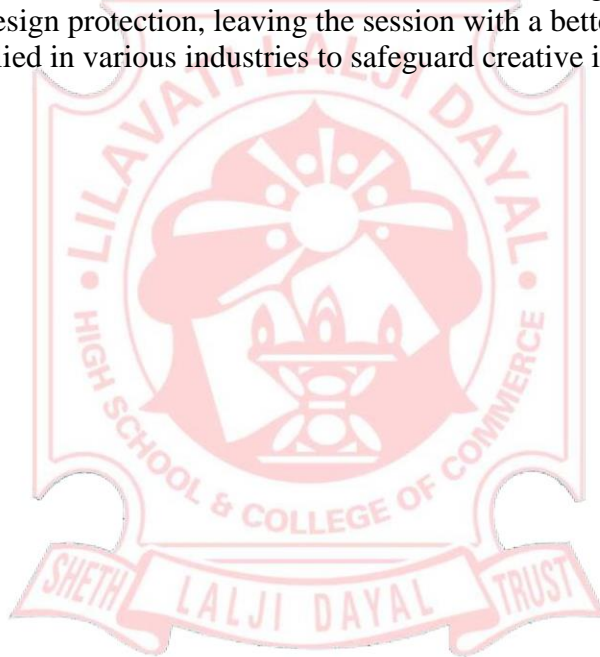
